FORTHCOMING WORKS

Lyle D. Bierma is completing an English translation of the Dutch book Johannes Calvijn: Zijn Werk en Schriften, by W. De Greef (Kampen, 1990), for publication by Baker Book House in 1993. He is also preparing an annotated English translation of an early German "commentary" on the Heidelberg Catechism, Vester Grundt, by Caspar Olevianus (Heidelberg, 1567).

William J. Bouwsma's book *John Calvin: A Sixteenth-Century Portrait* has been translated into Italian and is being published by Laterza.

I. John Hesselink is revising his *Introduction to Calvin's Theology*, a commentary on Ford Lewis Battles' translation of Calvin's first *Catechism* (1538). Also, his essay, "Governed and Guided by the

FELLOWSHIPS & AWARDS

Meeter Center Fellowships were awarded this past summer to Eun Seon Lee of Tae Shin University, Korea, and to Gon-Taik Park of Chong Shin College and Seminary, Korea. Cornelis Van der Kooi, recently appointed to the faculty of the Vrije Universiteit, received the Emo F. J. Van Halsema Fellowship for research at the Meeter Center.

Scholars having faculty status at their institution may apply for a Meeter Center Fellowship for summer study at the Center. The appointment carries a stipend of \$2,000 and the use of an office in the Center. The Emo F. J. Van Halsema Fellowship is offered to ministers in the Reformed tradition to support their research in Calvin and Calvinism and awards \$500. Applications for these fellowships are available from the Meeter Center and must be returned by January 1, 1993 to be considered for the following summer.

The Society for Reformation Research offers the Miriam U. Chrisman Travel Fellowship of \$1,500 every other year to a graduate student who needs to travel abroad to do research on a doctoral dissertation. The award competition is open to all students of European history, 1450 to 1650, whose topics deal with religious history in some way. Application should be made by January 1, 1993.
