Guidelines for Calvin College Undergraduate Students Participating in Health-Related Activities Abroad and Commitment to Adhere to Guidelines

Calvin College recognizes the value of participating in educational activities abroad and students are encouraged to take part in health-related projects outside of the U.S. These activities may be organized by Calvin through semester abroad and interim programs or other Calvin-affiliated programs or arranged privately by students. *Students participating in any of these programs are expected to read the AAMC and Department of Justice guidelines, complete the GAPS online workshop and commit to adhering to the standards presented in these resources by signing this document.* A copy of the signed document should be returned to your pre-health advisor and the leader of the healthrelated international activity.

Why is it necessary that students be informed of these guidelines?

- Medical schools are not interested in applicants who perform medical procedures for which they have not been adequately trained or place their own safety or that of any other person at risk and exceed safety guidelines when working outside of the U.S.
- So that students understand how their experiences should inform their applications to professional schools. For example, bragging about medical procedures (for which students have not been adequately trained) performed during overseas experiences is viewed negatively by admissions committees.
- Reports of work performed abroad that does not adhere to ethical standards will raise red flags in the minds of admission committee members resulting in a negative application review.
- Students should begin to model ethical behavior in a medical care setting in preparation for a career in which such decisions may be commonly required.
