The Symposium will feature four plenary sessions and several breakout sessions. Keeping with our recent tradition, the Symposium follows the <u>Kuyper Conference</u> held at Calvin April 2-4. The Kuyper Conference and the Henry Symposium share a "hinge" event, in this case the Pruis Rule of Law Lecture which will feature <u>Dr. Anthony Bradley</u> of the Acton Institute. Dr. Bradley's lecture scheduled for 11:00 am on April 4 will be the last event of the Kuyper Conference and the first event for the Henry Symposium. Discounted registration for both events will be available at the conferences' websites.

The Symposium is open to all scholars and practitioners and will include the annual Henry Lecture, featuring Dr. Michelle Kirtley, Senior Research Analyst in the Department of Molecular Genetics & Microbiology, Duke University, and Co-Chair of the <u>Association for Public Justice</u>. We will also host a special plenary session recognizing <u>Corwin Smidt</u> and the <u>"gang of four"</u> (Smidt, John Green, James Guth, and Bud Kellstedt) for their contributions to the study of religion and politics. Finally, we're delighted to continue partnering with the <u>Center for Public Justice</u> which will host their annual Kuyper Lecture on Thursday evening.
